

## **Year 1 Phonics Screening Check**

#### Information Evening for Parents and Carers

#### What is the purpose of the Phonics Screening Check?

- The purpose of the Phonics Screening Check is to assess how well children can apply the phonics skills they have been taught up to the end of Year 1 and identify pupils who need extra help with this area of the curriculum.
- The Phonics Screening Check only assesses whether a child can decode at the expected standard. It does not assess reading comprehension.

#### Who participates in the Phonics Screening Check?

All schools across England are expected to administer the Phonics Screening Check to pupils at the end of Year 1 and, in some cases, at the end of Year 2.


#### When is the Phonics Screening Check?

- Schools must administer the phonics screening check within the 1-week period from Monday 10 June 2024.
- There is no set day to administer the check.
- Children are not expected to take the check at the same time, as it will be undertaken on a one-to-one basis.


### What does the Phonics Screening Check look like?

- It is not timed but is expected to take between five and nine minutes.

- The check consists of 40 unrelated words that your child will be asked to read one at a time. If a child reads a word incorrectly, the administrator is not allowed to provide feedback and ask them to re-read the word.
- There will be 20 'real' words and 20 'alien words' (non-words).
- 'Alien words' (nonsense words, pseudo words) are a collection of letters that will follow phonics rules your child has been taught, but don't mean anything. Each of the 'alien words' is presented with a picture of a monster/alien. Your child will need to apply their knowledge of GPCs to read these correctly, showing that they understand the phonics rules behind them.

# How will the check be administered?

- The check will be administered in a quiet, comfortable space.
- The check can only be administered to each child once.
- The check will be administered in accordance with the Standards and Testing Agency's Phonics Screening Check Administration Guidance.
- Schools are monitored during unannounced monitoring visits from the local authority in order to ensure that the administration of the check is in line with the guidance.

## **Specific access arrangements**

The check may need to be adapted for some pupils with specific needs. Access arrangements should be based primarily on normal classroom practice and must never advantage or disadvantage pupils.

- Rest breaks
- Sound buttons
- Changing the font
- Changing the font size
- Having fewer words per page
- Coloured overlays

## How will the results be used?

- All schools will report their pupil-level Phonics Screening Check data to their local authority.
- The threshold mark is communicated to schools at the end of June, after the test has been taken and all schools have submitted their pupils' scores.
- If you child achieves the threshold mark and above, they are deemed to be working at the expected standard.
- We will not tell the children their results.
- Your child's result will be shared with you, as with every other National Assessment such as SATs. (This will be at the end of the academic year within reports.)

#### How to support your child in learning their GPCs and blending

- Continue daily reading of home reading books and practise alien words.
- If your child is struggling to decode a word, help them by encouraging them to say each GPC in the word from left to right and add sound buttons if needed.
- Blend the sounds by pointing to each one. For example, e.g. /c/ in cat, /p/ in pat, /ng/ in sing, /ee/ in been. Next move your finger under the whole word as you say it.
- Use the phonics pages in the middle of your child's reading record and sound mats provided at the family consultations to practise GPCs.
- Play the free games on 'Phonics Play' website (Phase Three and beyond).
